

## Himax Breaks Ground on New Preschool for Employees' Children Set to Open in 2026 to Foster a Family-Friendly Workplace

Fulfill Government Policies and Corporate Social Responsibilities. Center to Offer Premium and Flexible Childcare Services

**TAINAN, Taiwan – Oct. 25, 2024** – Himax Technologies, Inc. (Nasdaq: HIMX), an industry leader in fabless display driver ICs and other semiconductors, announced the commencement of construction for its new "Himax Preschool". The groundbreaking ceremony was led by Chairman Dr. Biing-Seng Wu and CEO Mr. Jordan Wu, along with senior executives, at Himax's Tainan Fab 2 campus. The preschool, located at Tree Valley Park, Tainan, is being built on company-owned land, and will accommodate 200 children of employees. Construction is scheduled for completion by the end of 2025 with trial operations beginning in July 2026 and the official opening in August 2026.

In response to the government's Early Childhood Education and Care Act and to fulfill its corporate social responsibility, Himax established the preschool to provide childcare for employees' children. The preschool will help employees balance family and work, while enabling them to focus on their duties without personal concerns.

The preschool will be built within Himax's Tainan Fab 2 campus in Tree Valley Park, with a total floor area of about 7.9 acres, plus an outdoor activity space. It plans to have 10 classrooms, accommodating up to 200 children, primarily aged 2 to 6, mainly serving employees' children. The preschool's teaching faculty and childcare will be managed under consignment by a renowned early childhood education institution in Tainan, ensuring top-quality education and comprehensive care for children. The childcare services are designed with employees' needs in mind, accommodating their work schedules and offering flexible, extended childcare hours to foster a family-friendly, work-life balanced workspace.

The construction of Himax's preschool reinforces the company's commitment to employee welfare and represents a key step in corporate social responsibility. Through the preschool, Himax aims to support employees in nurturing children and boost their happiness. Additionally, it seeks to strengthen employees' commitment to the company while attracting and retaining top talent.

In addition to continuously promoting family-friendly measures to ease the pressures of balancing work and family for employees, Himax also offers comprehensive health support, including medical checkups, health seminars, and on-site medical consultations for its employees, creating a supportive workplace environment.
